POLICE

FIRE

There were six call outs last month as well as the election of the Captain, Lieutenant and Secretary-treasurer.

The Chief took part in a conference in Fredericton on November 23rd.

A plaque was given to Councillor John Bellefleur in honour of more than 20 years of service as a fireman. He was also named honorary fireman.

The Chief wishes to remind people to be careful with wood burning appliances, Christmas trees and overloaded plugs this time of year.

DOWNTOWN

Santa Clause arrived last Sunday in collaboration with the Fire Department. Over 350 gifts were distributed to kids. The activity was a great success.

Thanks and congratulations to the people responsible for the downtown decorations.

WATER

Sewer lines have been cleaned. Citizens are asked to be careful what they send in the sewers.

COMMUNITY HEALTH COMMITTEE

Discussions were held with the regional board concerning the cost to our citizens who travel to Edmundston for dialyses.

Miscellaneous services now available in Grand Falls will be explained to citizens by the hospital administrator shortly.

SUICIDE PREVENTION

A meeting was held on December 12 to plan Suicide Prevention Month activities next February.

FALLS VILLA

A grant has been received from the Social Development Department to replace the roof of the Nowlan Residence and for the purchase of equipment at the manor.

FINANCE AND ADMINISTRATION

Many committee meetings were held concerning the 2013 budgets and the general insurance contract.

Turkeys

2012-090 that the tender received from Grand Falls Super Store in the amount of \$1.49 a pound plus tax for the purchase of turkeys is accepted. Carried

Policy 2012-01 – alcoholic beverage use

Jacques Lafrance / Arthelin Rossignol,

2012-091 that Municipal Council adopts policy 2012-01 on alcoholic beverage use as presented. Carried

2013 budget – general fund

Renaud Ouellette / Harry MacPhail,

that the amount of \$10,056,324 is the total operating budget of the 2012-092 municipality, that the amount of \$7,491,294 is the mandate of the municipality for next year, and that the tax rates are \$1.45 and \$1.4250. Carried

Council notes that there will be no tax increase in 2013. Mayor Keeley clarifies that our tax rate is 6¢ lower than the average rate for municipalities in New Brunswick and that the 2013 budget was increased 1.414% in all. This was managed notwithstanding the new unconditional grant formula which decreased the amount for Grand Falls by \$27,000 and property assessments which have not increased at the same rate as past years in the municipality. These are all factors that contribute to decreasing municipal funds.

2013 budget - water and sewer fund

Renaud Ouellette / Jacques Lafrance,

2012-093 that under paragraph 189 (4) of the <u>Municipalities Act</u>, the total operating budget of the Water and Sewer Department for next year will include revenues of \$1,754,164 and expenses of \$1,754,165. Carried

It is noted that there will be no tax increases in 2013 for water and sewer.

Transfer to reserves

Renaud Ouellette / Jean-Paul Proulx,

2012-094 that the amount of \$155,321.57 be transferred from the general operating reserve fund for sick days to the non-vesting future employee benefits fund- general. Carried

2012-095 that the amount of \$55,000 be transferred from the general operating fund to the non-vesting future employee benefits fund – general. Carried

Renaud Ouellette / John Bellefleur,

2012-096 that the amount of \$ 345,000 be transferred from the general operating fund to the general capital reserve fund for equipment. Carried

PLANNING COMMISSION

The planning commission, as we know it, will be dissolved as of December 31st, 2012. Tasks and files will be transferred to the Northwest Regional Services Commission on January 1st, 2013. We trust that the new commission will be able to offer the same services at lower cost without causing our citizens additional traveling for said services.

Twenty three permits were issued within the municipality in November for a total value of \$1.6 million.

100.2 (b), 101, 102.1 (1) and 190.01 (3) of the Municipalities Act to issue tickets, start proceedings in Provincial Court, enter upon any property at all reasonable times and issue notices for dangerous or unsightly premises, and;

2012-106 Considering that Council has received a request from Miss Nancy Lebel (for Michael Caron, actual owner) to operate a financial advisor office on the ground floor operated by Miss Lebel and a two bedroom apartment located on the second floor occupied by a person other than Miss Lebel. The said property is located on the lot with PID 65009516 and located at 87 Évangéline Street;

Considering that Section 66 of the said act prescribes that Council must ask the Commission for its opinion on the said by-law project;

Considering that Section 68 of the said Act prescribes the publication of public notices relative to the adoption of such a by-law;

COUNCIL INTERVENTION

Regional fire service study

Mayor Keeley explains the study that is proposed for the region. We are still waiting for Saint-André to decide if they will participate. He reiterates that this project has nothing to do with municipal amalgamation and that the study could help identify a location for the next fire station, plan purchases etc.

Bilingual signage

With the WAC 2014 fast approaching, the Mayor is being asked the municipality's opinion on bilingual signage. He asks that local entrepreneurs respect their clients who are mostly bilingual. Signage remains their choice and should be influenced by the market.

The current Council was not mandated by the citizens to legislate on this matter. However, Council encourages bilingual signage and the Mayor reminds that there are funds available from some agencies to help cover costs for new signs.

Regional Services Commissions

François Picard is the commission's new manager. Mayor Keeley calls for calm within the current employees of the planning and solid waste commissions for the time being. We still don't know where the manager's office will be.

Council – 6 month anniversary

Mayor Keeley thanks Council for their work and confidence in him. He likes the job of Mayor and thanks everyone involved.

Northern Construction and Broadway Place - purchase of land

The documents should be signed in the near future.

Office closure

Administration offices at the municipal building will be closed from December 24th, 2012 to January 1st, 2013, inclusively. A phone number will be available for emergencies.

Snow on sidewalks

Council asks the media to remind citizens not to push snow onto sidewalks or in the roads as this is against municipal regulations.

Holiday wishes

Council wish Happy Holidays to citizens and employees.

PUBLIC INTERVENTION - other

Claude Gagné

Mr. Gagné informs Council about an accident that happened at the shopping mall exit. He requests that the municipality take steps to diminish the number of accidents at this location such as limiting exits to right turn only.

Mayor Keeley mentions that this has been requested in the past but was refused by the shopping mall. He proposes that the municipality obtain legal advice in this matter.

MEDIA INTERVENTION

L'Étoile (Cataract)

Mr. Goulet requests more information concerning the commemoration of the War of 1812. The Mayor explains that the activities in general will take place on March 2nd and 3rd, 2013, in collaboration with the Winter Carnival.

Mr. Goulet also asks if the museum will be moved to the Malabeam Tourist Centre. Mayor Keeley informs that it will not. An interpretive centre will be built in the tourist centre.

Acadie Nouvelle

The journalist remarks on the speeding problem along Madawaska Road. A meeting will be held with interested parties to discuss solutions.
