Job Summary

Reporting to the Coordinator of Land Use Planning Services, the incumbent mainly performs various tasks of a complex nature related to land use planning, the issuance of development permits / inspection of buildings, the application of various orders, the preparation and presentation of exemptions. He or she attends various public meetings of planning advisory committees. He or she carries out controlled visits to the sites, solves various problems and ensures the compliance of the projects. In addition, he or she implements and updates infrastructure data in the municipality's geographic information system.
