Rezoning request – 3 Lajoie Street

  - 4. THAT the provisions regarding parking, area of buildings and units and all other provisions and general provisions of the *Town of Grand Falls Zoning By-law* apply *mutatis mutandis*.
  - 5. THAT one sign for frontage structure is permitted on the main building..
  - 6. THAT this said sign has a surface area no greater than 2.23 m². Carried
